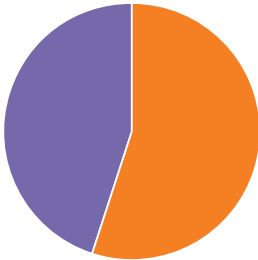

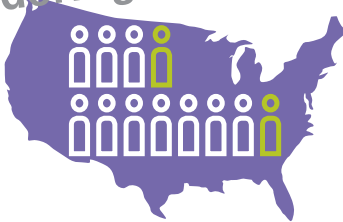

## The Most Common Causes of Disability

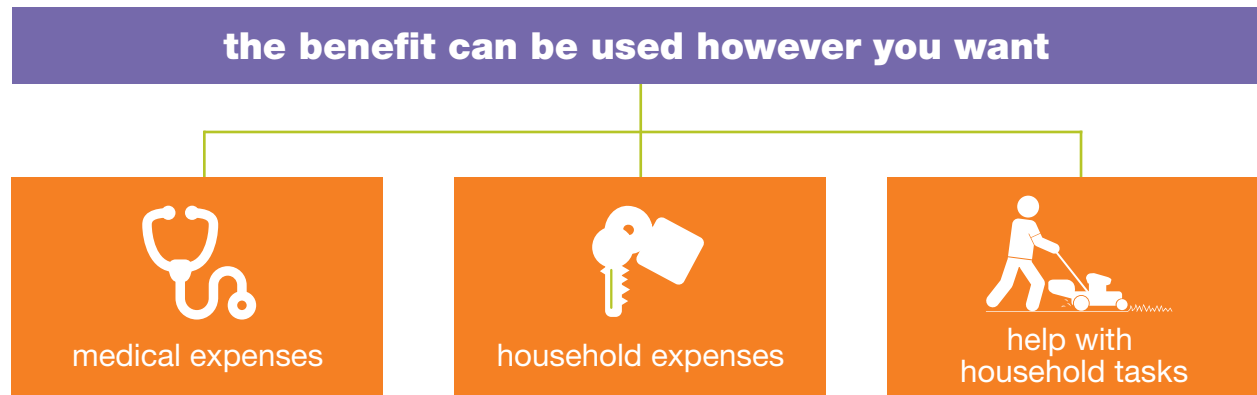


Less dramatic and much more common illnesses like cancer, heart disease or diabetes cause the majority of long-term disabilities.<sup>3</sup>

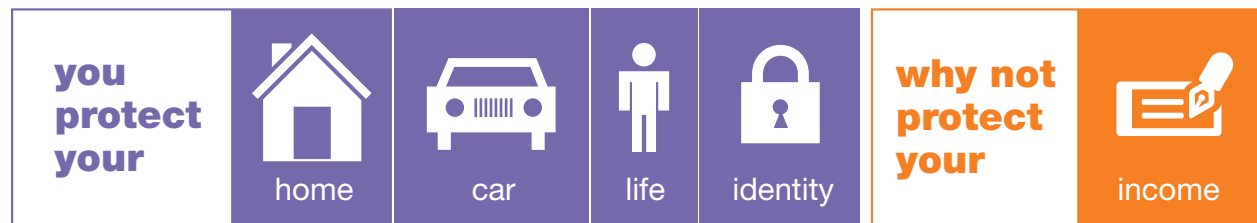
